

GENERAL TERMS AND CONDITIONS OF HIRE TRUCKS

1. Terms of payment are strictly via EFT and Credit Card (We do not allow any of our vehicles out without a Valid Credit Card (Copy front and back).
 2. All payments must be made with immediate effect. Cheque payments are not accepted. If paid by cheque service will commence after the funds have completely cleared and has been made available by the bank and the cheque has been honored by the paying bank. (14-21 Days). All reservations will be cancelled until satisfactory clearance.
 3. Our vehicles will not be permitted to leave our premises without the payment reflecting in our bank account. (Proof of payment will be required)
 4. All business is subject to the divisions trading terms.
 5. By paying on any quote/invoice you indicate that you have read through and accept our Terms and Conditions inclusive of the service level agreement for all groups which can be found on <http://www.lasky.biz>
 6. For transactions conducted on a cash sale basis, Logistics Amalgamated Sky (LA Sky) retains the right to claim any outstanding monies owed from the credit card as provided by the hirer prior to a vehicle rental.
 7. The Client warrants that all information provided to the Company from time to time is accurate, complete and up to date.
 8. The client is liable for all costs incurred for the delivery and collection fees on vehicles.
 9. The client is liable for the costs incurred for any and all overtime relating to Drivers and Crew.
 10. NB – The Company will use all reasonable endeavors to deliver the Vehicle to the Client on the date and at the time as agreed by both parties in writing but does not guarantee timeous delivery.
 11. Please note that a holding deposit is required, should you not incur additional charges we will process your refund within 10-15 working days after the hire is returned.
 12. Should you have a monthly hire with Logistics Amalgamated Sky (LA Sky), please note that the top up for your hire is required by the 4th of any given month.
 13. Should the vehicle not be returned on the date and time agreed the vehicle will then be regarded as stolen.
 14. The Company has the right to claim back on the Credit Card or the Deposit supplied.
 15. PENALTIES APPLY ON AN HOURLY BASIS FOR ALL VEHICLES THAT RETURN LATE.
 16. In the event of the Vehicle not being returned to the Company's premises from which it was collected, or any other place expressly agreed to in writing by the Company, a collection charge at the rate specified on the Rental Agreement, or, if not specified, at a rate decided upon by the Company at its sole discretion (Not exceeding R300.00 per hour).
 17. Please note that should you make payment via credit card, there will be a standard 3% surcharge for handling fees.
 18. Should you cancel your hire with us, we will automatically charge 25% or R2500 (whichever is highest) Cancellation Fee.
 19. Please note that a refueling surcharge will be applied if we need to refuel the vehicle. Maximum Load Capacity:

I hereby acknowledged that I am familiar with the maximum load capacity of the vehicles (Inclusive but not limited to supply chain and hire of flat deck-, flat bed-, drop sides-, flat with uprights 2.4m-, crane-, fork-, tail lift-, kombi-, bakkie-, refrigerated-, 1Ton-, 2Ton, 2.5T, 3Ton, 5Ton, 6T, 8T, 10T, 6m-, 12m-, 20T-, 22T-, 34T-, super link-, taut liner-, side tipper-, abnormal load-, curtain side- and enclosed trucks and 6m-, 12m-, temperature controlled reefer containers) that I am hiring.
- In the event of a client hiring a vehicle with the intent of using his / her own trailer, the company takes no responsibility for any form of over loading.
- The client will be held liable for any damages for whatever reason incurred through an overload.
